REGULATIONS: SONG-WRITING SECTION

1. The song-writing section is open to all songwriters. All material must be country.
2. Contestants entering this competition **must perform their song** at the festival **or arrange for their song to be performed on their behalf. 3 copies of lyrics must be supplied with your entry.**
3. Solo / duo / group - harmony permitted. Your performance at the festival must be "live". A backing track can be supplied in the form of a CD.
Your OWN backing band or acoustic guitar will be permitted on stage. No resident backing band supplied.
4. Song entered must be unpublished and original at time of judging.
Under no circumstances can the song or performer be changed from the heat to the grand final concert.
Songs previously placed at the Charters Towers Country Music Festival are not eligible.
5. **This section will be judged at the festival. All songwriters or their chosen performers will appear at the festival.**
The song writing will be divided into heats depending on the number of entries and **the highest 3 placegetters will then showcase their song on Sunday night during the Grand Final Concert.**
Judging will be based on quality of song writing, not of performance. (Judging criteria being made up of lyrics, music, and combination). The songwriter not the performer will be awarded. This section will not be eligible for the overall grand prize.
6. The judges opinion is just that, an opinion, based on his or her knowledge and experience in the country music industry and should be taken in the spirit it is made.
7. The decision of the judges will be final and no discussion or correspondence will be entered into regarding their adjudication.
